

Controlling Person - Self Certification Form (CRS)

Please read these instructions before completing the form.

Regulations based on Organization for Economic Co-operation and Development (“OECD”) Common Reporting Standard (“CRS”) require EBSI¹ to collect and report certain required information based on controlling person of an entity account holder’s tax residency status.

根據經濟合作與發展組織 (簡稱「經合組織」) 的共同匯報標準 (簡稱「CRS」) 的規定，光大證券國際¹ 必須根據實體帳戶的控權人士的稅務居住地蒐集及匯報所需相關資料。

Each jurisdiction has its own rules for defining tax residence. In general, tax residence is the country in which you live. Special circumstances (such as studying abroad, working overseas or extended travel) may cause you to be resident elsewhere or resident in more than one country at the same time (multiple tax residency).
